Dear Mr Mansbridge,

Sorry to return again to the meeting 8th July arranged to discuss drawing 8296/14 and the relevant plans. I had hoped at this meeting that we would discuss these plans and in particular my contention that the specification of the RSJ used for the portal column gives scale to drawing 8296/14 which leads to a planned height at the road end of the shed of 12.5m. I had also hoped that the full sized plan (8296/13?) would also be made available as well.

This was the drawing shown at a previous meeting arranged by Councillor Anglin with your Planning Department on November 25th 2013. I was lead to believe at this meeting that this was an authorised drawing and although it appeared to be without dimensions its dimensions can be gauged quite accurately by the specification which is clearly given on the fixing details of drawing 8296/14.

I would like it put on record that these plans were not shown or discussed in any detail at the meeting and only mentioned in passing.
