You may not have seen the copy of my email to the BBC/You and Yours about the Ombudsman but if you look at the correspondence I sent Rebecca about them you will see by their second Inspector being used to hide a wrong perpetrated by South Tyneside Council.

When I first wrote to you I was aware that the Council were misusing their own complaints procedure to 'edit' my complaint as it progressed through the system till it emerged out the other end as something the LGO won't touch, such as a matter of opinion. I also noticed that the Council were prepared to misrepresent what what actually went on to the Ombudsman so they found for the Council rather than the complainant.

This was being repeated when I complained that UK Docks had built their cover too high and was in breach of the second condition.

I'd worked out that they should have asked UK Docks to rebuild it to the correct height but it would have been no use to them so they would have had made a retrospective planning request which may have been turned down. This was not an option that neither they nor their main clients, the Port of Tyne nor NEXUS wanted, and they found someone on the Council prepared to say that their cover or shed was approved when it wasn't.
