Hi, found it.

The meeting appeared to be arranged between Anglin, Cunningham and Graeme. Haig was not scheduled to go but just appeared as it were. He brought the meeting to an end when he noticed me taking too much interest in the drawing 2/3rds hidden under Cunningham's folder. I never did manage to get a copy. Think it was the full sized drawing of the the shed by the Agents in August but it did not matter as there were enough details on 8296/14 to determine the planned size of the shed. 15.6 x 12.2m at the river end.

The TGA minutes (edited by Anne on the 21st Dec) record Haig saying that the drawing was a 1996 one. Julie pointed this decision out to me.

Michael,

As chair of the TGA I feel it necessary to respond to your various e-mails and seek clarification of certain points.

With regard to your e-mail below of Monday at 16:10 to Cllr Anglin, you infer that you have measured the structure down at the boatyard and - as you have stated - appear to have dimensional evidence that the structure is one metre wider than designed.

I note in your e-mail of yesterday evening that you appear to have measured the structure from outside the boatyard site, and I am unsure how accurate that could be, especially given that you claim your measurements are to within 5 cm of accuracy.

You wrote your e-mail on Monday in a fashion which appears to give the impression that you are writing on behalf of the TGA as a group; if this were the case I would have expected you to follow protocol and that committee members would have given their consent to this or at least have been made aware of your new evidence.

The TGA could then have ascertained the validity of your findings and agreed to subsequent action; at this point you cannot give any assurance that your measurements are accurate or provide an answer to Peter Cunningham as to what method you used to obtain them. As a result your measurements cannot be verified and taken as being accurate.

In my opinion the only way to get these measurements with the accuracy stated would be to gain access to the boatyard and physically measure between the various points on the footings. I am therefore concerned that, purporting to represent the TGA as a whole you have somehow gained access to the site without permission and taken these measurements.

In order to put my mind at ease, can you therefore explain how you have obtained your findings?

Also, in your e-mail of Monday at 16:10 you make reference to myself and state that I informed you that the meeting at the Town Hall would be a formal meeting with structured protocols. In fact, I never said that the meeting would be formal as per the e-mail I sent out prior to this meeting. I am not happy to be misquoted in official correspondence you sent out to council officials.

If you want to communicate with the Town Hall on a personal basis with your comments and views on the boatyard issue do not use the TGA as a platform to do this. Any official correspondence from the group as a whole is to be done through the secretary, and any new evidence or information is to be presented to the TGA committee as a group. Any such information can then be progressed in structured manner as required.

Please revert with a full explanation of the method used to measure the width of the structure so that we, as the TGA can be satisfied of their validity.

Hi Melanie,

I've found this. Not only is Hayley Johnson's action in trying to silence me probably illegal but Peter Cunningham should have been hauled across the coals for his last email (20th).

Instead, his boss Gordon said in an email on 15th Jan, "The dimensions of the steelwork have been checked on site and they are in accordance with the measurements shown on the approved drawings. The variation in the angle of the pillars is not considered to be material." The drawings (8296/1A) were not approved.

The pair of them should have been hauled across the coals when I complained to Gordon's boss Mr Mansbridge but I was ignored.

What is very telling, is, I got an email from Graeme a few hours later trying to silence me- I'll post that across when I find it.

I've copied this back to myself because I don't want to lose it again

I have sufficient skills in surveying to be able to measure the width of the structure without access to the site and can say with confidence that it is 13.20m wide give or take 0.05m. The towers are vertical and it would seem to me that it is reasonable to assume that the footings, laid in 2001, are the same width.

We still need to receive a copy of the date stamped approved drawing from 1996.

Cllr John Anglin,

Inappropriate Developments on the Riverside.

Thank you for the summary of the meeting of the 25th Nov. I agree that this is a reasonable record of the meeting. However, the TGA Committee members were made to understand by the current Chairman, Graeme Watson, that this would be a formal meeting 'standard meeting with structured protocols'. So far details of the meeting have been word of mouth only, as you say no records exist, which makes the dissemination of information to the wider membership difficult.

I would like to comment on your first point about drawings seen and have attached three images to help make this clear. First a sketch of the plans I think we were discussing at the meeting (image on the left) and second, a detail from the drawing, date stamped 5th Sept, provided by Peter Cunningham. The photo of the structure completed in early September speaks for itself.

I have measured the structure concerned and it is a meter wider than the date stamped plan provided. Therefore the footings placed in 2001 must have been set a meter wider as well. An image was forwarded to Peter Cunningham showing that the current structure is too short to accommodate the Nexus Ferry; not suitable for purpose?

I maintain that the existing construction has not been built to the plans as circulated by Peter Cunningham. I am therefore requesting a copy of the plan presented at the November meeting as represented by my sketch. I am concerned that the planning department is about to allow a building that is not being constructed to an approved plan an occurrence of which I have personal experience.

This is an important issue to residents of the Riverside who need to be kept fully informed, particularly as it is understood that Mr Wilson or his representatives are currently in the pre-planning stage with the council regarding further works.

I believe therefore that any future meetings regarding this matter should be formal and recorded.

I took no minutes as is customary at these informal meetings.

For your record I am sure all would agree :

1. The Exec representatives of the Group accepted that the construction had been made legally as per drawings seen.
2. The Exec representatives accepted that Items 3 and 4 which had not been complied with by the building company previously had now been properly addressed.
3. Concern was expressed that the building as approved would be unfit for purpose (eg not big enough to take in the Ferryboat) but this was accompany problem until/ or if, additional construction was made.
4. Concern was expressed as to the fact that there had been rumours that the Company was preparing to apply for further Planning Permission for at least one more building of about the same size.

It was agreed that until Planning Permission was requested no other action or re-action could be made by the Council. Indeed, that if a request was made the final decision could end up being made by persons from outside the Borough.
